

# REYVOW™ Financial Assistance Guide



A new class of medications has been approved by the FDA for the acute treatment of migraine in adults. These drugs are referred to as serotonin (5-HT) 1F receptor agonist. Reyvow is currently the only one of these oral medications on the market.



Many insurers have not yet decided if or how they will cover Reyvow. If you are prescribed Reyvow, the pharmaceutical company is offering a financial assistance program to help cover the cost.

## I Have Been Prescribed Reyvow. What Financial Assistance Programs Exist To Help Me?

### I Have a Private/Commercial Insurance Plan



This category includes insurance plans provided through an employer, purchased with subsidy support from the Affordable Care Act (Obamacare) or purchased privately.

#### *Highlights of Reyvow Savings Card*

If you have commercial drug insurance, you may be able to pay as little as \$0 for your first fill of Reyvow. For your second and subsequent fills, your health plan must cover Reyvow to continue to pay as little as \$0 per fill. This offer is for up to 12 months of Reyvow and expires on December 31, 2021. The Savings Card is subject to an annual maximum benefit of \$3400. This means that you may be required to pay out of pocket depending on your health plan and copay model if the maximum annual cap is reached.

# Steps To Get Your Savings Card

STEP 1 - Your doctor writes you a prescription for Reyvow.

STEP 2 - Obtain a Reyvow Savings Card online, by phone or with the Patient Brochure or Savings Leaflet. The Patient Brochure or Savings Leaflet may be distributed to you by your doctor's office.

STEP 3 - Activate your Savings Card. You can activate online\* at [Reyvow.com/savings-support](https://www.reyvow.com/savings-support) or over the phone by calling 1-833-REYVOW1.


STEP 4 - Take your prescription (if your doctor did not call it in to your pharmacy) and Savings Card to your regular retail pharmacy to be filled. The Savings Card includes important information you need to provide the pharmacist to connect your prescription to the offered savings. If you have any trouble or are ever told you must pay more than \$0, please call 1-833-REYVOW1 (1-833-739-8691).

*Details about the Savings Card offer beyond 2021 are not yet available.*

\* To download or activate your Savings Card online, visit <https://www.reyvow.com/savings-support>. Choose "Get a Card." You will then be prompted to complete the following steps:

- 1 Answer the Savings Card eligibility questions – please confirm that you are a resident of the US or Puerto Rico who is 18 years of age or older, NOT enrolled in a government-funded prescription program.
- 2 Provide your contact information.
- 3 Read and accept the terms and conditions for Electronic Signatures in Global and National Commerce ("E-Sign") Act Disclosure.
- 4 Read and sign the HIPAA (Health Insurance Portability and Accountability Act) authorization\*\*.
- 5 You will receive a verification code via email or text message. The verification code will need to be entered to complete your Savings Card activation.
- 6 If you have a physical Savings Card, enter in the card information to complete activation.
- 7 Your Savings Card can be emailed to you, texted to you or may be printed. It is now activated and is ready to be used at your local pharmacy.

\*\* Your HIPAA authorization is needed to allow Lilly to work on your behalf to help you pay as little as possible for Reyvow.



## I Have Medicare, Medicaid or other Government Insurance Plan

The Reyvow Savings Card is not available to patients whose medical insurance is provided by state or federal programs, like Medicare and Medicaid. This restriction is true for most savings card programs.

The Federal Government does not allow people who are receiving insurance benefits through Medicare, Medicaid, etc. to use co-pay assistance, discount or savings cards offered by pharmaceutical companies. The intent is to steer patients to lower-cost generic drugs and not to support higher-cost brand-name drugs. Unfortunately, there are no generic/biosimilar medications in the class of 5HT1F receptor agonists (ditans) and won't be for years to come.

Patients with Medicare Part D who meet all program eligibility criteria may receive Reyvow free of charge from the Lilly Cares Foundation Patient Assistance Program. Some of the eligibility requirements are:

- Must be a permanent, legal resident of the US or Puerto Rico
- Must have been prescribed Reyvow and have Medicare Part D
- Must not be enrolled in Medicaid, Medicare's Extra Help program or Veterans benefits
- Must have spent \$1,100 on prescription medications as a Medicare Part D patient
- Must have a household income under the Annual Income Limit:

## I Am Uninsured

The Reyvow Savings Card is not available to patients who are uninsured. Patients without insurance who meet all program eligibility criteria may receive Reyvow free of charge from the Lilly Cares Foundation Patient Assistance Program. Some of the eligibility requirements are:

1 Must be a permanent, legal resident of the US or Puerto Rico

2 Must have been prescribed Reyvow and be uninsured

3 Must not be enrolled in Medicaid, Medicare's Extra Help program or Veterans benefits

4 Must have a household income under the Annual Income Limit
